Still toying with children's safety

Six years since the publication of our first report and online marketplaces are still facilitating the sale of dangerous toys into the UK. The British Toy & Hobby Association is calling on the new UK government to take urgent action – now is the time to close the existing harmful legal loophole for good.

INTRODUCTION

Online marketplaces have a significant role to play in e-commerce and the overall retail landscape. They have become increasingly popular with consumers given the convenience they offer in terms of search, payment, and delivery, as well as providing more choice.

Despite online marketplaces now being well-established business models globally, regulations and enforcement have failed to keep up with the changes in supply chains. This has sadly resulted in unacceptable levels of non-compliant and unsafe toys being too easily sold to consumers unknowingly – something the BTHA has evidenced to different governments over the course of the last six years.

Toy safety is core to the work of the BTHA. Our members of reputable toy businesses invest heavily in producing safe, quality toys that enrich the play experiences of children all across the UK. It was based on our value to drive best practice in toy safety across the industry that in 2018 we started testing toys purchased through online marketplaces as we had concerns that the toys were unsafe. What we have discovered since then is shocking.

Due to limited regulatory action by previous governments our concerns remain. Online marketplaces have had many years to improve the safety of their platforms, and in fact, frequently communicate new measures they have put in place to keep their consumers safe. We wanted to put these measures to the test to see if there had been an improvement in the number of unsafe toys being sold.

We have therefore conducted another BTHA investigation into a range of toys sold by third-party sellers via online marketplaces. This report investigates toys sold by the four online marketplaces who we have monitored since 2018; AliExpress, Amazon, eBay, and Wish, as well as seven other increasingly popular online marketplaces; Etsy, Groupon, Joom, OnBuy, Shein, Temu, and TikTok.



BACKGROUND

Legislation

All toys sold in the UK should be safe.

In the UK toys must comply with the Toys (Safety) Regulations 2011 ('the Regulations')¹, which is the main legislation controlling the safety of toys. There are also several other areas of relevant safety and consumer legislation that will be applicable depending on the toy. Within the Regulations are requirements for defined 'economic operators' involved in the sale of toys, which means manufacturers, importers and distributors, each have legal responsibilities to ensure that toys are only placed on the market if they are safe.

However, current legislation is not appropriate for the global supply models that we see today and the diversity of businesses selling to UK consumers from all over the world. For too long, toys sold by third-party sellers through online marketplaces have been able to avoid complying with UK legislation due to two main reasons:

- Online marketplaces are not clearly defined as any of the above economic operators which means they do not have any legal responsibilities to ensure the safety of toys being sold by third-party sellers via their platforms.
- 2. Third-party sellers operating through online marketplaces are often based overseas outside the jurisdiction of UK enforcement authorities. This means enforcement action cannot be taken against third-party sellers even when unsafe and non-compliant products have been identified.

Although all toys should comply with safety requirements, this legal loophole means it is too easy for illegal and unsafe toys to be sold in the UK.

Previous BTHA investigations

The BTHA has been evidencing unacceptable levels of dangerous toys being sold through online marketplaces by their third-party sellers since 2018. We have continued to do this under our campaign, 'Still Toying with Children's Safety', to raise awareness with consumers of the dangers of buying toys from third-party sellers, and to call on the government to close the existing loophole by making online marketplaces legally responsible for the safety of all toys sold through their platforms.

Throughout this time, we have purchased, assessed, and tested 620 toys and showed that the majority (86%) of toys purchased from third-party sellers do not comply with the UK's legal safety requirements. The findings have not improved in the six years investigating the same four online marketplaces. An overview of all the results since 2018 can be found in **Appendix 1**.

THE 2024 RESULTS

Headline findings

For this BTHA investigation, we purchased 75 toys covering a wide range of toy categories and suitability for different age ranges. These were all purchased from third-party sellers across 11 online marketplaces.



Our sample purchases contained high levels of non-compliant toys across all 11 online marketplaces with no online marketplace having less than an 80% non-compliance rate, and seven online marketplaces having a 100% non-compliance rate.

A summary of the individual online marketplace overall results can be viewed in **Table 1**. A full list of the 75 toys, including more details on the toys, third-party seller details, and potential hazards can be view in **Appendix 2**.

Key non-conformance issues

As with each year, we have collated the top non-conformance issues found with the toy samples from the limited testing we were able to conduct.

Small parts

Small part failures can lead to young children choking when they swallow small parts that they should not have access to. Children under three years are vulnerable to this issue and therefore toys that contain small parts must be aimed at 3+ years. 27 toys from our sample failed this testing, 16 had missing age restrictions warnings, and 15 missed the hazard statements related to small parts.

There are several ways this fault can be found:

- a) A toy that is designed and aimed at children under 3 years is supplied with small parts already available within it.
- b) A toy that is designed and aimed at children under 3 years is tested and, under abuse testing which reflects normal use, a small part is released due to poor construction or strength.
- c) A toy intended for children over 3 years that contains small parts or releases them under testing and does not include the correct warning statement or 0-3 logo on the packaging or in marketing online. In our experience these often include pictures of babies using the toy. This can confuse consumers and lead to the toy being given to the wrong child and is therefore unsafe.

It should be noted that the age determination must be completed carefully and a toy that is aimed and suitable for children under 3 cannot be labelled as 3+ to avoid testing and assessment for small parts.

Improving the age determination of toys by ensuring the correct warnings are present, changing marketing online to state the correct age, and showing the correct age of child using the toy would significantly improve failures in this area. For certain toys, improvements in construction and testing to check that abuse testing does not produce small parts is also essential.

Traceability markings

These are the UK address of the manufacturer or their representative, the UKCA and/or CE mark, and a unique product identifying number. Whilst there have been some improvements on some online marketplaces with an increase in UK addresses, 52 toys from our sample still had incorrect, incomplete, or missing markings for the UK, and 45 for EU markings.

Traceability markings are legally required on toys to ensure effective action can be taken in the event of a safety issue. Improvements in compliance with this requirement can ensure toys are traceable and can be effectively recalled or withdrawn from sale.

Packaging / plastic film thickness

18 toys from our sample were found to include sheet materials over the legal size that were under the required thickness of 0.038mm. When over this thickness the plastic will not be drawn onto the face and therefore is not a suffocation risk.

The change to using thicker film material will prevent this hazard.

Cords

Cord lengths are controlled under EN71-1 to prevent the chance of strangulation by entanglement around the neck. Nine toys from our sample were found to fail this aspect.

Ensure toys comply with the cord length requirements of EN71-1 by inspection and/or testing.

METHODOLOGY

Toy selection

The 75 toys in our sample were purchased by an independent purchaser with the brief to select a wide range of different types of toys from third-party sellers. We could have chosen to purchase toys we know are likely to fail from past experience, but we did not as we deliberately wanted to take a fairer approach. Throughout all of the BTHA reports, we have always actively sought to pick a mix of unbranded toys to exclude potential counterfeit lines.

The toys and packaging were assessed on delivery, alongside how they were marketed online. We assessed the appropriate warnings and labelling, and in some instances, this determined how the toy would go on to be categorised. The marketing and packaging also determined what test would be applied. For example, if a toy was marketed for a baby in descriptions and photographs, the toy would be tested against the standards for children under three years old even if the seller had put a 3+ age warning label on the package.

Unlike in previous reports where only a selection of toys were put through independent testing due to cost, all 75 toys were tested by an independent certified laboratory. This is because it has always been our assertion that if all toys are tested then more of the toys previously categorised as 'illegal' due to technical non-compliances like missing conformity marks, would be determined 'unsafe'. Our 2022 report, which tested all products, found much higher rates of unsafe toys for this reason.

Due to the high cost of testing all samples, and wanting to investigate more online marketplaces, we had a smaller sample size on each of the individual websites. Ten toys were purchased from each of the four online marketplaces we have investigated since 2018, AliExpress, Amazon, eBay, and Wish, and five toys were purchased from each of the other seven online marketplaces.

Toy categorisation

In this report we have categorised toys as either: 'unsafe', 'illegal', or 'compliant'. These have been defined in the following ways:

Unsafe

These toys pose a risk to the health and safety of consumers.

- Samples that fail testing to a safety standard.
- Samples that fail a safety standard due to missing safety warnings (e.g., missing 3+ age warning).

Illegal

- Samples that have incorrect labelling due to an additional but inappropriate warning (e.g. additional 3+ warning on an under 3 years toy).
- Samples that have missing traceability labels (e.g., UKCA/CE mark, traceability number or UK address etc.).

Compliant

 Samples that are labelled correctly and pass the (limited) testing applied are categorised as compliant.

Testing standards


Only **three** testing standards have been used in this investigation:

- EN71-1 Safety of Toys. Mechanical
 & Physical Properties
- EN62115 Safety of Toys. Electrical Safety
- REACH Annex XVII Entry 51 & 52 Phthalates

There are a much wider range of standards that would be applicable to the toys so the **full compliance** of any of the 75 toys has not been assessed. This demonstrates that the failures above to such a small selection of applicable standards means that even basic compliance is not being applied. If we were able to conduct further testing as part of our investigations, we may find that the toys that we have currently categorised as 'compliant' may actually be 'unsafe'.

To understand the level of requirements that toys need to meet to comply with UK regulations, we have used one of the 75 toys as an example. You can see the full list of compliance requirements for the 'Electric Train' purchased through eBay in **Table 2**.

STILL ON SALE

The Crocodile Story

The BTHA has continued to monitor one particular product throughout the six years we have been investigating online marketplaces as it demonstrates many of the issues found with the online marketplaces handling of product safety issues.

The initial product was purchased from a third-party seller on Amazon in 2018 and, since then, its presence and availability on the Amazon online marketplace has been frequently checked and further samples have been purchased at regular intervals.

The product has failed EN7-1 testing six times, failed fire and furnishing once, and has been recalled on three separate occasions.

Despite this, third-party sellers have easily been able to re-list the product and it was even marketed to us as 'Amazon's Choice'.

The toy crocodile has most recently been found on eBay in May 2024. The sample purchased also failed EN71-1 testing. Seemingly identical listings can be seen today across multiple online marketplaces investigated in this report.

Analysis of toys previously listed on the UK Product Safety Database

Following previous BTHA investigations, we have notified the Office for Product Safety and Standards (OPSS) on the toy samples that have undergone independent testing.

112 toys were notified on the UK Product
Safety Database from the 2021 and 2022 BTHA
investigations that were purchased through
AliExpress, Amazon, eBay, and Wish because
there was a consumer safety risk. These lines have
been checked on each individual platform to identify
seemingly identical lines. This is because we know
from the toy crocodile sample above that recalled
lines can still end up for sale by the same
or different third-party seller.

'Seemingly identical' lines are those that use the same photographs and packaging to the recalled lines. The BTHA accepts that these products could be a different model entirely, or the manufacturer could have updated their product and made it compliant since the initial notification was issued.

In total, out of the 112 notified toys, **70% were still found on sale** on the same online marketplace. The analysis can be found in **Table 3.** A full list of the individual seemingly identical toy analysis can be found in **Appendix 4**. This includes details of the original product and corrective measures taken from the UK Product Safety Database, and example links of seemingly identical products still available.

It should be noted that in previous reports re-testing of seemingly identical lines have shown failures for the same reasons as the original recall.

RECOMMENDATIONS

Regulatory action

Consecutive governments in the UK and globally have so far failed to take sufficient action to better regulate online marketplaces and our latest results show that online marketplaces are still failing to stop dangerous toys being sold to consumers in the UK through their voluntary measures.

After six years campaigning on this issue, the BTHA is therefore pleased to see the new UK government set out its intention to regulate online marketplaces through the **Product Regulation and Metrology Bill**². This is essential to ensure there is a level playing field for all businesses selling in the UK, and to safeguard consumers – in particularly children and their families. In respect of online marketplaces, the Bill aims to deliver more protection to consumers by:

"Identifying new and emerging business models in the supply chain, ensuring the responsibilities of those involved in the supply of products, such as online marketplaces (which are online platforms that connect third-party sellers to consumers for distance sale and purchasing of products), are clear and modernised for increasingly complex supply chains, to support consumers' confidence in the products they buy and whom they buy them from."

With a Bill going through Parliament, now is the time to close some of the harmful legal loopholes that are failing to keep children safe. The latest findings in this report highlight some of the key areas that need addressing to ensure that online marketplaces cannot be used to avoid toy safety requirements in the future.

1. The legal duties of online marketplaces need to reflect the high level of risk that products purchased via those platforms present to the health and safety of consumers. Online marketplaces should be recognised as economic operators with clear obligations to ensure the safety of all toys sold, and which truly recognise the role online marketplaces play for products to be supplied to consumers. These obligations should include proactive steps and checks to ensure all toys sold are safe prior to thirdparty sellers being able to list the products. These enhanced responsibilities must reflect the unique risks that the online marketplace supply model has on consumers given that we have consistently found approximately 80-90% of products sold by third-party sellers via online marketplaces fail to meet standards in the UK.

Third-party sellers are based all over world and online marketplaces help facilitate the sale of their toys into the UK in several ways – from marketing and payment to fulfilling deliveries. If the third-party seller is based outside of the UK, then there is often no recognised operator responsible for the toy within the UK. Recognising online marketplaces as an economic operator alone will not guarantee safety, but it will make online marketplaces duties equivalent to traditional models of retail.

- 2. Introduce an enforceable liability provision to ensure that consumers can seek redress for defective products. In previous reports, we proposed that government consider mechanisms for imposing direct liability for defects of products in the production or marketing of goods sold via an online marketplace on the provider of the online marketplace, as well as the third-party seller. This remains a gap in the current wording of the new Bill and is necessary to bring online marketplace liability in line with traditional models of retail which the government has stated as its ambition. Without it, under the current drafting of the Bill, consumers would not be necessarily entitled to seek a refund of the purchase price from online marketplace providers, or to claim damages from them for wider losses suffered.
- 3. Strengthen enforcement powers by including provision for collective consumer redress for non-compliance in the Bill. The monetary value of the non-compliant products purchased in our investigations are relatively low, and therefore disproportionate to the costs and effort involved for consumers to seek relief personally. This needs to be addressed to strengthen consumer protections by permitting a 'relevant authority' to have the function of securing redress for consumers. Collective redress for failures affecting a large number of consumers will have a much higher value overall and therefore could be more sufficient as a tool to enforce against online marketplaces who facilitate large quantities of non-compliant products to consumers.

4. A clear definition of online marketplaces in legislation that captures the diversity of these more complex business models. Online marketplaces are now wellestablished supply models but even in the six years we have been investigating, online marketplaces themselves have evolved to respond to consumer demands. While we refer to any online service which facilitates the supply of products to consumers as an 'online marketplace' these take many forms from more traditional marketplaces to social media platforms and fulfilment services.

Uncertainty over defining these types of business models has enabled online marketplaces to avoid complying with UK regulations for too long so it is paramount that any new legal definition contained within primary legislation is broad enough to capture all existing and future marketplaces. The new product regulations and requirements that will apply to online marketplaces need to recognise the multinational corporate structure of online marketplaces and variety in how they operate in practice. This is key for determining who is the responsible actor within the marketplace for complying with any new product regulations and requirements.

CONSUMER ADVICE

Until there is regulatory change we continue to raise awareness of the issue with consumers, particularly around key buying periods throughout the year, to offer advice when purchasing toys from online marketplaces.

Top ten tips when buying online:

- Be more careful about buying from thirdparty sellers on online marketplaces – do not assume that any safety tests have been carried out. Look for sellers you recognise and trust – the toy brand directly or a responsible retailer, or if you purchase from a name you don't recognise, be more cautious and do more research and checks.
- 2. Make time to research before you buy search for the company or brand that makes the toy and include it in your search on the online marketplace. If you are purchasing a branded product, compare the toy against the company's own website.
- 3. Be careful of going for the cheapest price if something looks too good to be true, it probably is. We have found in our investigations that unsafe toys are increasingly being sold at the same price point, so always look beyond the price before you purchase.
- 4. Check who the seller is. Look at the address details on the listing, see which country they are based in. Do they have a clear address to return the item if you are unhappy?

 Do they have a track record of selling the type of item you are buying (and therefore know what the safety requirements are)?

 Do they have genuine reviews?
- of the toy and see if the description, images, and warning labels match up e.g., is the toy labelled for over three years but has a picture of a baby? Is the marketing showing small parts or long cords but advertised for under threes?

- 6. Check reviews carefully. Some reviews are fake so look carefully at the comments, are they too good to be true, are there genuine comments about the toy and its features and the buyers experience?
- 7. Once you receive your toy, check if it has a UK address, check for a CE or UKCA mark and see if the packaging looks genuine.
- 8. Check if there are any age restrictions on the product, such as "not suitable for under three" and check that against the image used to sell the product. Make sure it is in fact suitable for a toddler and has not got small parts that could be swallowed.
- When your child opens a toy, stay with them and check for faults, detachable small parts, access to stuffing and loose or accessible batteries or magnets.
- 10. If you think the toy you have bought is unsafe or illegal write a review to warn other purchasers, report to the online marketplaces, and talk to your local Trading Standards.

FURTHER EVIDENCE

This is not only impacting toys

The BTHA was one of the first organisations to start purchasing and testing products bought from third-party sellers. The strong evidence of failures over several years by the BTHA and other industry and consumer organisations has covered a wide range of consumer products purchased from third-party sellers via a range of online marketplaces. This led to the regulator, the Office for Product Safety and Standards, to initiate its own online marketplace testing programme.

The breadth of work has shown the variety of unsafe products being sold to consumers, and the failures of online marketplaces to keep consumers safe – all building a strong case for the need for further regulation.

"Unsafe electrical products continue to flood online marketplaces due to a lack of regulation, putting consumers at serious risk. The new Product Regulation and Metrology Bill offers a vital opportunity to ensure these platforms are held to the same standards as traditional retailers. Effective regulation is important to stop the sale of dangerous products online.

It's essential that online marketplaces are held legally accountable for the products sold on their platforms and take proactive measures to prevent the sale of dangerous goods. Consumer safety is paramount if we are to prevent further deaths and injury from unsafe products."

Appendix 1. 2018-2024 overall results

The table below covers the full results from all BTHA projects since 2018. This covers toys purchased from AliExpress, Amazon, eBay, and Wish 2018-2024, as well the additional seven online marketplaces.

The overall 'unsafe' figures are lower in earlier projects due to less samples being tested. With more testing, we have shown that more toys categorised as 'illegal' would likely have been determined as 'unsafe'. The final column shows the overall non-compliance rate – this includes toys that have been defined as unsafe and illegal and therefore do not comply with the current UK law. This is exceptionally high at **86**% and shows the scale of the failure of online marketplaces to stop non-compliant products being sold by third-party sellers.

An online marketplaces case study

Online marketplaces have failed to take the necessary action to improve the safety of products despite being signatories of voluntary agreements with different governments globally for many years.

This specific case study of a toy crocodile originally sold on Amazon demonstrates the issues found with the online marketplaces handling of product safety issues.
